

## NORTHLAND FOUNDATION AWARDS GRANT TO AVINITY

**Richfield, MN - (2.15.16) - Avinity Senior Living (“Avinity”) is the recipient of a grant from the Northland Foundation to enhance independent living opportunities for older adults in northern Minnesota through the use of technology.**

Avinity has been awarded a one-year \$30,000 Northland Foundation grant for its *Age Well: Partners in Technology-Driven Support for At-Risk Older Adults* project at LEE Center in Hibbing. Northland Foundation, a regional foundation serving northeastern Minnesota communities, provides resources through its Grant Program to support social and economic justice in the region. This grant supplements previously awarded funds from the Minnesota Department of Human Services’ Live Well at Home grant program.

Through the *Age Well* project, Avinity is collaborating with The Lutheran Home Association (TLHA) to develop robust educational and advocacy programming and is leveraging TLHA’s advanced expertise in health monitoring technology. Additionally, Avinity has partnered with the Arrowhead Area Agency on Aging, to promote the project and advocate for sustainability with local organizations serving seniors, including St. Louis County caseworkers. Together, this partnership and grant funding will provide remote health and safety monitoring systems to current residents of LEE Center in Hibbing, a Section 202 HUD Housing, Avinity Independent Senior Living Community that serves seniors with qualifying incomes. The program targets residents who are at risk of needing to move from their homes to a higher, more costly level of care.

“We are grateful for the generosity and partnership of the Northland Foundation in helping Avinity provide the resources and technology to help older adults live safely and independently,” said Jennifer Zarth, Vice President of Philanthropy & Programming for Avinity and author of the grant proposal.

The implementation phase of the grant has kicked off with staff, caseworker, resident, and family educational sessions. Training and advocacy sessions will continue throughout the project as the technology is installed in the homes of LEE Center residents who opt-in for the program.
